**Member Classes:** Any exhibitor who is not a NCWHA member who enters in a member class will have an annual membership fee added to their show bill.

**CLASSES AND DIVISIONS: Please see the PWHA rules for more requirements**

**Open Gaited Breed/OGB:** Open to All Gaited Breeds Only. Maximum shoe size for all four feet: 1/2" x 1", caulks allowed

**All Breed:** Open to all trotting breeds, no gaited horses

**OGB/All Breed:** All gaited and trotting horses may participate

**TWH:** Tennessee Walking Horse only, maximum shoe size for all four feet: 1/2" x 1", caulks allowed

**SSH:** Spotted Saddle Horse Only

**AOT:** Amateur Owned and Trained

**OT:** Optional Tack – tack must be of the same discipline, no mixing of English and Western, with exception of Cavassons, which are allowed in ADP and CP Western Classes

**First/Second Year/Green as Grass:** Open to horses who are competing in their first/second year of showing regardless of age. Open to exhibitors who are competing in their first/second year of showing

**Horse of Color:** Open to horses who can be registered with a color registry

**Three Gait:** All 3 gait class participants must canter - no exceptions

**Classic Horse:** Open to horses who are 15 years old and over

**Trail Horse on The Rail:** Show clothes are not required, however boots and sleeved shirts are required. Professionals are not allowed to exhibit in this class. **Designed for the newbies to showing. ADP and OGB cross entries allowed. No other performance division may cross enter.** Entries to be judged on obedience and suitability as a reliable trail mount

**All Day Pleasure/ADP:** Maximum shoe size on all four feet: 3/8" x 3/4", factory keg shoes. No caulks allowed. ADP division may be designated as Open, per class list

**Barefoot Horse:** Any horse that does not have steel or any metal material on its feet. All four hooves on horses shown in this division should not exhibit nail holes or any evidence that shoes have recently been removed. No exception. The hoof on a Barefoot horse should not exceed 5 inches in toe length and heel height no higher than 2.5 inches

**Country Pleasure:** Maximum shoe size on all four feet: 3/8" x 3/4" factory keg shoes, whether flat heeled or with poured caulks, are allowed

**Trail Pleasure:** Maximum shoe size for all four feet: 3/8" x 3/4", caulks allowed

**Lite Shod:** Maximum shoe size for all four feet: 3/8" x 3/4", caulks allowed

**Limit Horse or Rider:** Has not won 6 or more blue ribbons in a class of more than 2 entries

**Novice Horse or Novice Rider:** Has not won 3 or more blue ribbons in a class of more than 2 entries

**Championship Classes:** To qualify for a championship class, the horse must have been shown and judged in a corresponding qualifying class

**Golden Ticket Class:** The Judge will award 10 Golden Tickets to the Exhibitor/Horse combination of their choice, throughout the entire show. If you receive a Golden Ticket, your horse will be invited to participate in the final Golden Ticket class.

**Versatility (V Classes):** All timed events must be ridden in a western saddle

**Pole Bending/Barrel Racing no canter classes:** If the horse breaks into a canter, a 5 second penalty per break will be added to the final time

### **Payment Rules:**

**ARRANGEMENTS FOR PAYMENT AND SIGNED RELEASES MUST BE COMPLETED PRIOR TO RECEIVING BACK NUMBER, NO EXCEPTIONS.**

Payment in full or a signed open check must be included with the entry to cover all show fees (Make checks payable to NCWHA). Online payment is also accepted and encouraged. Open checks may be left in the show office at the show but must be received prior to obtaining the entry show number. ZELLE OR CASH DEPOSIT can also be left with show office. Show numbers will not be issued until the entry is complete, including NCWHA signed releases. Show management reserves the right to refuse entries from exhibitors with outstanding bills.

Persons failing to pay their bill or leave a deposit at the show will be charged a \$50.00 service fee and interest accruing at the annualized rate of 6% until paid. A \$50 service fee plus additional bank charges will be added to All returned checks. If accounts are not settled after billing, NCWHA may pursue collection via Small Claims Court.

The listed stall and tack room fee covers Thursday night through Sunday afternoon. Early arrivals and late stays for horses need to be arranged beforehand with show management. Please contact Tammy Chance. Please indicate your arrival date on the entry forms.

Should NCWHA receive a bill for any early arrival or late departure that was not collected, exhibitors will in turn be billed double the fee, along with a billing fee of \$30.00. By signing the entry form you agree to all the rules set forth in this Show Premium.

**Stalls and Barn Assignments:** If stalls/tack rooms are needed, please reserve by 4/19/2024 – Tammy Chance on the Show Committee will handle stall assignments ([tachance2003@yahoo.com](mailto:tachance2003@yahoo.com)) . Please put in your stall needs with your entries. The posted stall assignments are final unless special permission is granted to change stall assignments.

**Bedding:** Bedding is not provided for the stalls. You can bring your own shavings or can purchase through the facility. No shaving purchases will be taken from NCWHA, all payments must go through Murieta Equestrian Center. Working out of trailers is permitted. You will, however, be charged \$35 per horse per day.

**Facility Rules:**

1. Please clean up after yourself and your horse. Areas left messy after the show will be charged to the organization and subsequently you will be billed for whatever the facility charges (minimum \$40), plus an additional billing fee of \$30. You must leave the facility in the same condition that you found it.
2. Horses may only be washed in designated wash racks areas only.
3. Absolutely no parking on the roadways or access ways is allowed on the fairgrounds. All trailers & vehicles shall be limited to designated parking areas so as not to block the fire lanes. A tow truck may be called if there are violations.
4. Horses are only allowed in the barn, warm up arena and in the main arena only.
5. No riding in the barns, on the lawns or on the roadways.
6. Dogs accompanying exhibitors and trainers must be managed at all times. Owners must clean up after their pet. If any complaints are filed, the pet will be required to be confined at all times.
7. No riding of motorcycles, bicycles, ATVs, or horses in the barns. Please observe the 10 MPH speed limit. Unlicensed drivers are not permitted to drive any motorized vehicle

8. Landscape materials used outside your barn area must be removed and the area swept clean. Vandalism, damage or displacement of Murieta Equestrian Center property or the property of any trainer, owner or exhibitors will result in a \$50.00 fine to all individuals involved in addition to any charges for damages.
9. Public drunkenness, aggressive, dangerous, or threatening behaviors toward any other person on the show grounds, show officials, show exhibitors, or guests will not be tolerated, and the offending individual may be asked to leave the grounds and may be barred from additional participation in the show at the discretion of the NCWHA Board and/or officials from the Murieta Equestrian Center. In addition, law enforcement may be contacted in order to keep the peace and public safety for all individuals and animals.

### **Horse Protection Act Rules:**

THIS SHOW IS FOR SOUND HORSES ONLY. ANY LAME, OR SORE HORSE WILL BE DISQUALIFIED FROM COMPETITION, NO QUESTIONS ASKED, AND WILL FORFEIT ALL SHOW FEES.

1. Any persons on Federal Disqualification cannot transport horses to this show and can only participate as a spectator.
2. No plastic wrap, hoof wrap, hoof bands, chains, other action devices, leg wrapping, or full blinders will be allowed on show grounds.
3. All exhibitors, owners, and trainers must comply with the Horse Protection Act (the HPA) and cooperate fully with representatives enforcing it.
4. Horses with any bilateral hair loss, scarring, callous, or granulated tissue on the pasterns or coronet area indicative of the practice of soring, showing signs of lameness, or any way of going that is considered "bad image" will be excused from classes entered and may be asked to leave the grounds. Concerns of possible HPA violations may be brought by the judge or show management and will be subjected to additional inspection. Show management may ask any entries in violation of the HPA to leave the grounds.
5. Any person with ANY HIO suspension or disqualification is in effect during the show for violation of any provision of the HPA may not participate in this show in any capacity other than as a spectator. Prohibited activities include: showing or exhibition of horses, hauling horses to and from the show, or caring for horses on the grounds. Any suspended person must restrict themselves to the grandstand, rest room, and concession areas and may not linger where horses are kept.

### **Showing Rules:**

1. We follow the Plantation Walking Horse Association rules. Go to [pwhaca.org](http://pwhaca.org) to read. All NCWHA rules also apply. Exhibitors are responsible for knowing and understanding the rules.
2. Exhibitors may not engage in conversations with the judge. Any questions or concerns about your horse or class must be submitted in writing to the show office or may be discussed with the judge after the end of the show. All decisions of the judge are final. Any person who fails to comply with this rule will have all high-points removed for the year and all awards and prizes will be revoked.
3. Gate holds (3 minute maximum) will be granted for just cause upon notification of the Gate Person.
4. Time-outs may be granted by the judge when the exhibitor pulls into the center of the arena. Time-outs will be granted for replacement of shoes, replacement of broken equipment, or in other instances where the judge finds valid reason. An exhibitor may be excused from the ring by pulling into the center of the arena and obtaining permission from the judge or ringmaster to be excused. Entries that are excused prior to the completion of the class will be deemed not judged and therefore that class will not qualify the entry for a championship class.
5. Shoe sizes will be checked by the show committee only if there are questions brought by the judge, show management, or other exhibitors as to whether a horse is wearing shoes legal for the class the horse will be exhibited in

6. Helmets are ALWAYS REQUIRED for any exhibitor 13 years of age or younger WHILE MOUNTED. Helmets are REQUIRED for any exhibitor 17 years of age or younger while participating in timed event classes. The Show Management and Show Committee reserve the right to prohibit a youth from riding on the grounds if these rules are violated.
7. Show Management and Show Committee reserve the right to accept or refuse service and/or deny entries and/or cancel entries, disqualify exhibitors, prohibit exhibition of entries and cancel premiums without claims for damage. Additionally, any individual who exhibits disorderly conduct or non-sportsman-like conduct may be asked to leave the grounds and all high points associated with that person (individual points or horse points) will be null and void. No refunds will be made to those who are asked to leave the grounds for disorderly conduct, non-sportsman-like conduct, or suspected HPA violations.
8. Cross entering between TWH divisions is not allowed. All TWH divisions are eligible to show in OGB and TWH Pleasure classes.
9. A versatility high point award will be awarded to the entry who earns the most points in designated versatility classes. A reserve high point award will be awarded to the entry with the next highest number of points. Points will be awarded based on placing (1st=6pts, 2nd=5pts, 3rd=4pts, 4th=3pts, 5th=2pts, participation=1pt.) and will follow the horse/rider combination. A horse may be ridden by both a youth and adult rider as appropriate. A tie will be broken by most blue ribbons won. No preshow sign up is required and there is no fee to participate. Points will only be counted for one class in each division. A horse can earn points in only one of the trail, barrel, and pole bending classes available, though horses may enter more than one class in a division. The show management will automatically count points in the class where the entry placed higher if multiple divisional classes were entered.
10. Stallions shall be barred from Youth Exhibitors Classes.
11. The Lead line class is open to riders 7 and under. All entries must be led by an adult exhibitor. One or two side walkers are acceptable as needed for rider safety.
12. **The Walk Only Class** is open to all beginning riders of any age who are not yet ready to show at a gait or trot. Riders eligible by age may cross enter in the lead line class but riders may not cross enter into any other under saddle class. Class will be judged and tied. Show clothes are encouraged but not mandatory (long pants, boots, and helmet are mandatory). The class will be judged primarily on the rider's equitation. Safety is encouraged and so schooling equipment (rainbow reins, safety stirrups, etc.) is acceptable. One adult per entry may be present in center ring for safety. An adult may also be present as a header in the lineup.
13. **Adding and Scratching classes:** classes may be added to your entry at the show with no penalty. Changes should be made with show office **BEFORE** each session. **No refunds will be given for classes not scratched with the show office or gate at least one class ahead of the class to be scratched. Regular rail classes added at the gate will be charged an add fee of \$3/class added.**
14. **It is the exhibitors responsibility to confirm any changes to the daily class schedule! Updated schedules are available in the show office every morning.**



## NEW NCWHA Members' Class Rules 2024

1. Points will be awarded to NCWHA members who ride in designated NCWHA member classes at approved shows. Shows must be approved for points by the NCWHA Board prior to the start of the horse show.
2. Classes are open to any gaited horse of any division and may be ridden English or western.
3. Annual or lifetime membership must be completed and paid prior to the end of the show for the member to have points counted.
4. Points will be based on the member's placing: 5pts for 1<sup>st</sup> place, 4pts for 2<sup>nd</sup> place, 3pts for 3<sup>rd</sup> place, 3pts for 4<sup>th</sup> place, 1pt for 5<sup>th</sup> place. All participants in the class will receive 3 participation points regardless of placing. Points awarded will be doubled for Mayfest and Oktoberfest.
5. Member's classes at each approved show will consist of the following five classes: Open 3 gait, Open 2 gait, Amateur 2 gait, Youth 2 gait, Novice 2 gait.
6. A member may show in the Novice class only if that member has not previously won an end year NCWHA Members' Class high point.
7. Points may only be earned by one horse in one members' class each show.
8. Members may show in multiple classes and count points as they are eligible.
9. Members may earn points on multiple horses if rules 10 and 11 are followed.
10. The same horse may be shown in the Open 3 gait, Open 2 gait, and Amateur 2 gait classes for class placings; however, points will only count in one class for end year awards. Points will be awarded to the member who shows that horse first at a given show.
11. Horses ridden in the Youth 2 gait OR Novice 2 gait may not be ridden in any other members' classes. If a horse is ridden in the Youth 2 gait OR Novice 2 gait class and the same horse is shown in a second members' class, all class awards will be forfeited for that horse and rider(s) and the class retied. In addition, all points toward the end year high point for that class will be forfeited.
12. All points earned by members who have their horses in training with a NCWHA member trainer will be awarded to that trainer for the end of year Trainer of the Year Hi Point Award.

**Representations:** By signing this Release of Liability and Indemnification Form ("Release Form") in connection with the Mayfest horse show ("Show") sponsored by the Northern California Walking Horse Association ("NCWHA") on May 3-5, 2024, to be held at Murieta Equestrian Center ("Murieta") in Rancho Murieta, California, I hereby:

- 1) Agree to abide by The Horse Protection Act, the current PWHA Rule Book, Murieta's rules and all other governing laws and rules while at the Show;
- 2) Represent that my entries meet all applicable Show eligibility requirements;
- 3) Agree to accept as final the decision of the NCWHA Board of Directors on any question arising under applicable rules;
- 4) Agree to the terms of the "Release of Liability and Indemnification" set forth below; and
- 5) Agree that I will not allow any individual to ride or handle any horse owned by me on the Show grounds unless and until such individual has signed and submitted a copy of this Release Form to the Show Secretary.

**Helmet Requirements:** All riders 13 years of age and under are **required** to wear protective helmets whenever riding and/or showing on the horse show grounds at all times. **NO EXCEPTIONS!** All riders **under 18 years of age are required** to wear protective helmets when participating in **timed event classes**. Riders of all ages are **strongly encouraged** to wear protective helmets while showing, particularly in timed event classes. If a rider 18 or over decides not to wear a protective helmet, that rider accepts the risk of head or other injury and all liability for any injury. The rider (or parent or if under 18 years of age) must initial here \_\_\_\_ to indicate that the helmet requirements were read and understood:

**Release of Liability and Indemnification:** In consideration of participating in the Show, I hereby release NCWHA and all of its directors, officials, agents, employees or any of their representatives or assigns (collectively, "Indemnitees"), from any and all liability for any act of negligence or want of ordinary care on the part of Indemnitees. I hereby waive, release and discharge Indemnitees from any and all claims of liability for injury or damage to me, to any other individual(s), to my or other animals or to my property arising out of any claims of liability for injury resulting from my horse(s) 's or my participation in the Show, which shall be binding upon my executors, heirs and assigns.

I expressly waive any rights I may have under California Civil Code Section 1542, which states that **"A general release does not extend to claims which the creditor or releasing party does not know or suspect to exist in his favor at the time of executing the release, which if known by him, might have materially affected his settlement with the debtor or released party."**

In any court proceedings or other causes of action brought by me or prosecuted for my benefit where this Release Form is upheld, I agree that I will indemnify and hold harmless Indemnitees against all claims, demands and causes of action, including court costs and actual attorneys' fees incurred.

**I acknowledge that horseback riding is a sport which carries inherent risks of injury and damage to me, to other individuals, horses and my property. I knowingly assume all risks of participating in horse-related activities and horseback riding, whether known or unknown, including, but not limited to, injuries, death or property damage from: mounting, dismounting, riding, walking, grooming, feeding, use of facilities or riding arena, falling off a horse, riding without a helmet, or otherwise relating to horseback riding or otherwise use and control of, or lack thereof, of any horse ridden or present at the Show.**
